## Subject: Invitation of Bids for purchase of Servers

On behalf of the National Internet Exchange of India, sealed tenders are invited from the reputed and well experienced Suppliers and authorized reseller/ selling agent/ distributor for supply of items as per attached Annexure I.

GENERAL TERMS & CONDITIONS

- 1) Bids should be valid for a minimum period of ninety days after the due date.
- 2) The bidder should have a minimum turnover of Rs. 10 crore consecutively in the last two financial years from IT hardware sales. Also, it should have executed at least one purchase order worth more than Rs. 10 lac for Servers. Proof of the same needs to be submitted.
- 3) Quotations should be submitted in two separate sealed covers. First Cover indicating "COVER FOR TECHNICAL BID" should consist of only technical specification of the items offered along with make, model, literature, pamphlets, drawing and the Certificate about being the Authorized Representative etc. This cover should include complete technical specification, make model name of supplier/manufacturer and commercial terms of the equipment/items offered. Price column in this cover should be kept blank. EARNEST

MONEY (as mentioned in Annexure III) SHOULD ALSO BE SUBMITTED IN THIS COVER i.e. along with the technical bid.(see para 14 : evaluation criteria for further documents required of in the Technical Bid).

Second cover indicating "COVER FOR PRICE BID" should include the same details of first cover and also price details (see Annexure II). Both Covers should be kept in a Third sealed bigger cover. This cover addressed by name to the officer signing this inquiry should be submitted before the due date and time.

4) Envelope should bear the inscription as follows:

#### "Quotation for the supply of Servers"

- 5) The bids must reach NIXI on or before the due date i.e. 11<sup>th</sup> March,2008 by 3 PM. Bids received after due date and time are liable to be rejected. In the event of due date being declared a Holiday by NIXI, the date for submission of the bids will be in following working day at appointed time and venue. Bids shall be opened on the same day at 3-30 PM in the presence of Bidders, who are present.
- 6) The rates should be quoted in Indian Rupees for delivery and installation at the premises indicated in the Annexure III. All prices should be fixed and should not be subject to escalation of any description. The rates must be inclusive of all taxes, freight, transportation, packing, forwarding, handling etc.
- 7) Complete Technical Details along with make, model, number complete specification, pamphlets, and literature of the systems highlighting the special feature of their offer should be supplied along with the quotation. It must be specifically mentioned whether quotation is strictly as per tender specification/conditions. If not, deviations must be spelt out specifically. In the absence of this the quotation will be rejected.
- 8) Please give the Registration number of the firm along with the CST No./VAT No. allotted by the Sales Tax authorities in your quotation.
- 9) NIXI reserves the right to accept or reject any bid or cancel the tender proceeding without assigning any reason whatsoever.
- 10) Incomplete quotations are liable to be rejected.
- 11) Bidder shall sign all pages of quotation.
- 12) In case of any discrepancy between rate mentioned in the figures and words, the later shall prevail.
- 13) Full payment shall be made by the purchaser on receipt, satisfactory installation, commissioning, testing and acceptance of the equipment as well as receipt of pre receipted bill in triplicate. Details of payment schedule are mentioned in Annexure.
- 14) Evaluation Criteria:
  - (a) Bidders are required to quote for all the items of the tender failing, which their bid shall be treaded as unresponsive. Duly

constituted committee shall first open and evaluate Technical Bids only. Price bids for only those bidders shall be opened whose technical bid is found to be in order as per tendered specification/conditions. Technical bid <u>MUST</u> include the following

- (b) Bidder should provide the customer list with contact details where these products have been earlier installed by them.
- (c) The Bidder should be ISO 9000 certified. Copy of valid certificate must be enclosed. Please note that ISO certificate should be in the name of Bidder. Certificate in the name of any other entity will not be acceptable.
- (d) Bidder should justify their ability to provide support in all 9 NIXI locations. Bidder should also provide the contact details with address of local offices in these locations.
- (e) The bidder must either be an OEM Vendor (manufacturer) of the servers OR must be an authorized priority partner of the manufacturers for this bid. Letter from the manufacturer supporting the installation in NIXI should also be submitted in case the manufacturer is not directly bidding.
- (f) <u>Please refer to Annexure -3 regarding 3-3-3 year onsite</u> warranty with 8 hrs resolution time. The bidder must attach (in the technical envelop) a letter from OEM regarding compliance with this resolution time.
- (g) Bidder should provide single point contact for fault reporting and also include escalation matrix.
- 15) The purchaser may waive any minor infirmity or seek any clarification, if so desired.
- 16) NIXI may or may not procure all the items. It also reserves the right to increase or decrease the quantity of items.
- 17) INSPECTION

The purchaser or its representative shall have the right to inspect or to test the items to confirm their conformity to the ordered specifications. The supplier shall provide all reasonable facilities and assistance to the inspector without any charges to the purchaser. In case, any inspected or tested goods fail to confirm to the ordered specifications, the purchaser may reject them and supplier shall either replace the rejected goods or make all alternative necessary to meet specification required free of cost to the purchaser within the specified delivery schedule

18) <u>EARNEST MONEY DEPOSIT</u>:

(i) Each quotation must be accompanied with Earnest Money Deposit mentioned in the Annexure III, which shall be in the form of Demand Draft/Pay order in name National Internet Exchange of India, New Delhi. Quotations received without Earnest Money deposit are liable to the rejected. Earnest Money is liable to be forfeited and bid is liable to the rejected, if the tenderer withdraws or amends, impairs or derogates from the tender in any respect within the period of validity of the tender.

(ii) The earnest money of all the unsuccessful tenderer will be returned as early as possible after the expiration of the period of the bid validity and after issue of the purchase order. No interest will be payable by the purchaser on the Earnest Money Deposit.
(iii) The earnest Money of successful bidder shall be returned after satisfactory installation, commissioning, testing and acceptance of the equipment.

#### 19) WARRANTY ON SITE

As per details given in the Annexure III. It will be counted after installation and acceptance.

20) DELIVERY PERIOD

The Bidder must be in a position to supply the ordered items on very short notice. However, in any case, the delivery shall require to be completed within delivery period specified in the Annexure III. In case the supplier fails to deliver the items within stipulated delivery period, NIXI may recover Liquidated Damage as per clause 21, cancel the purchase order and forfeit the Performance Security.

#### 21) LIQUIDATED DAMAGE

If the supplier fails to deliver any or all of the goods within the period specified in the purchase order, the purchaser shall without prejudice to its other remedies, deduct as liquidated damage 1.5% of the price of the delayed goods for each and every week (part of the week shall be considered as full week) subject to maximum of 7.5% of the delayed supply value and the same shall be deducted from the bill(s) or any other payment due to the party.

22) All disputes are subject to the jurisdiction of courts in the National Capital Territory of Delhi and Agreement will be governed by and be construed in accordance with the laws of India.
