1. Aspiring Bidders/Contractors who have not registered in e-procurement should register before participating through the website. <https://eproc.karnataka.gov.in>
2. Before submission of online bids, bidders must ensure that scanned copies of all necessary documents are attached with bid.
3. Tenderers shall upload the valid & present certificate copies of PAN, GST No., Contractors Registration Pass Book for technical bid qualification eligibility.
4. All information required for bids must be filled and submitted online as per K/W - 5 document.

6. Conditional bids will not be accepted.
7. Sub-letting of work is prohibited.
8. Any Corrigendum/Modification will be notified in the Notice Board of the Office of SGB as well as through e-portal.
9. Necessary taxes and other deductions will be made from Contractor Bills.
10. The successful bidder will have to execute an agreement with **SGB** within 7 days of receipt of intimation, failing which his/her tender is liable to be rejected.
11. **SGB** reserves the right to accept/reject any of the entire tender without assigning any reasons.
12. The qualified tenderers should have to produce contractors registration book issued by the concerned authority for procurement of tender documents from e-portal. Applicant should submit proof of registration, latest income tax clearance certificate for the last 5 years obtained from the concerned Department as well as to submit financial turnover balance sheet for the last 5 years duly attested by the Chartered Accountant, while submitting the request for application for the Tender Schedule, which otherwise the application will be rejected.
13. The building work should be commenced with all earnestness within 15 days from the date of Work Order, failing which it would be presumed that he has no interest in the work and action will be taken to get the work executed through alternate agency.
